Exportation of plants and plant products from non-EU countries from 1 January 2021 to the UK

NPPO, the United Kingdom has recently amended the phytosanitary condition for importing plants and plant products from non-EU countries after withdrawal from the European Union. Accordingly, the ban for following crops is lifted and can be exported to UK from third countries including Sri Lanka with ordinary PSC.
