This has reference to the Director of Customs letter dated 18/04/2018, bearing reference number CUS/ICT/MISC/2018/05.

However, several shipping lines and CHA has pointed out that the Bill of Lading does not contain the net weight of the goods. Accordingly the ICT division has amended the system. Therefore, the CHA are expected to declare the exact gross weight found in the Bill of Lading in the CusDecs. Herewith, I am attaching the revised instructions with regard to submitting of the manifest details in the Customs Declaration (CusDec) by the Customs House Agents.

Please be good enough to circulate these instructions among your members. Also please inform your members that they can now key in these details in to the CusDec to be familiar with the new requirement. Manifest details in the CusDec will be made mandatory from 25/04/2018.
